




Food Culture Assessment & Plan

- Simple 13 questions based on FSANZ guidance
- Review of Food Safety Culture Indicators in four axes of
 - People, Purpose, Process, Proactivity as required by BRC



5. I know how to report any concerns I have about food safety






Reporting concerns

- Our average scores ranged from 3.2 to 4.5
- Knowing how to report concerns was relatively low score across all teams
- Decision to implement a Whistle Blowing Process




Where to from here
